# FUNDAMENTALS OF ENGINEERING (FE) EXAM INFORMATION INSTRUCTIONS FOR APPLICATION

(for VT students enrolled at time of examination)

## **ELIGIBILITY**

<u>Undergraduate</u> candidates must be within 12 months of graduation from Virginia Tech when they sit for exam. <u>Graduate</u> candidates must be within 6 months of graduation from Virginia Tech when they sit for exam.

# **EXAM FORMAT AND APPLICATION INSTRUCTIONS**

Application and test fees total \$225.00. The FE exam is a computer based test (CBT) that each student schedules to take individually at a local Pearson VUE location (https://ncees.org/exams/test-center-locations/)

You will register and schedule your appointment through your My NCEES account on the NCEES website. NCEES will approve the applicant, and email instructions for logging back in and scheduling individual exam time/location. Applicant will then select the exam location, and will be presented with a list of available exam dates for the appointment. If you are not happy with the choices, you can browse through the available dates at another NCEES-approved testing center.

#### **DPOR REGISTRATION**

Applicants must also register with the Department of Occupational and Professional Regulations (DPOR). While there is no deadline associated with the application to DPOR, the Engineer In Training (EIT) Designation is not issued until the EIT Designation Application is satisfactorily completed. DPOR will require a letter of good standing, which you may get from your Academic Advisor (list found at https://eng.vt.edu/academics/services-for-students/academic-advisors.html).

If you are applying prior to graduating from VT, you must include a letter of good standing. If you are applying after graduating from VT, you must include an EIT Reference Form.

#### **AFTER THE EXAM**

Upon successful completion of the FE exam, the candidate will be emailed instructions for completing the EIT Designation Application through the Department of Occupational and Professional Regulations (DPOR). While there is no deadline associated with the application to DPOR after passing the exam, the EIT license will not be issued until the EIT Designation Application is satisfactorily completed.

## STUDENTS WITH DISABILITIES

You must be registered with the Office of Services for Students with Disabilities, 310 Lavery Hall, to request accommodations for a disability.
